Sir,

A Statutory Warning has been issued by Rehabilitation Council of India on 14.5.2019 on the subject "Practicing without RCI Registration in Govt./Non Govt. Organization and by any private practitioner is an Offence under Section 13(3) of RCI Act No. 34 of 1992" (copy enclosed). The same is as under:

"Any person who acts in contravention of any provision of sub-section (2) shall be punished with imprisonment for a term which may extend to one year, or with fine which may extend to one thousand rupees, or with both".


In this connection, Hon'ble Minister (SW) has directed to convey that essential service during physical, mental & vocational rehabilitation in the lives of person with disabilities are technical in nature hence needs to be checked through a legal framework.

It is therefore, all departments of GNCT of Delhi are requested to comply with **Section-13 of RCI ACT.**
